5. Upon request, I may request that the local school board/district identify the knowledge, skills and competencies a student is recommended to attain by grade level and subject area to assist me as the parent/instructor in offering college and career readiness through home schooling.
6. Students released for home instruction do not earn Washington County School District credits. I accept full responsibility for my student and understand that he/she may not qualify for a high school diploma issued by the Washington County School District. Please refer to Policy 4100 Graduation Requirements/School Credits; Section 4.2

For students with IEP's or identified through child find: My decision to home school does not in any way imply that the school district did not provide a free and appropriate public education and I understand and agree that my student has no individual right to receive special education and related services which he/she would receive if enrolled in a public school in Washington County School District, unless I have arranged for dual enrollment consistent with state law, Section 53A-11-102.5 and Utah State Board of Education rule R277-438.

- d. The school-age minor's parent or guardian notifies the school district that the school-age minor's district of residence has changed.
